RE: T.M.A NO. 44386 IN THE NAME OF SOLLATEK ELECTRONICS (KENYA) LIMITED AND EXPUNGEMENT PROCEEDINGS THERETO BY MICROTECH ENTERPRISE LIMITED.

Reference is made to the above- mentioned matter and to my earlier directions on this matter dated 27^{th} July, 2020, the Notice of Motion Application dated 2^{nd} September, 2020 and the Registered Proprietor's Replying Affidavit dated 8^{th} October, 2020.

In view of the withdrawal of the application for rectification by Delta Electric and Communications Limited as per the contents of their Advocates letter dated 17th March,2020 has rendered the aforementioned Notice of Motion application and subsequent Replying Affidavit on the issue of consolidation of the proceedings a nullity because the application has now been overtaken by events.

The expungement proceedings against the registered proprietor by Microtech Enterprise Limited shall therefore proceed as follows in the interest of justice, in light of the withdrawal of the application for expungement by Delta Electric and Communications Limited and in view of progressing these expungement proceedings:

- That the registered proprietor herein shall file its Statutory Declaration within the next fourty-two (42) days from the date of this letter;
- That the Applicant for Expungement shall file a Statutory Declaration in reply, if any, thirty (30) days from the date of receipt of the registered proprietor's Statutory Declaration; and
- 3. That the filing of pleadings shall thereafter proceed in the usual manner including the parties fixing hearing dates in the Legal Registry and being heard thereon in the usual manner upon payment of the requisite fees.

The Advocates for the Applicant for Expungement had stated that they had filed written submissions in this matter, kindly but urgently provide a copy of the same as the said written submissions are not in the file. Should the same be availed further directions will be given accordingly.
